Hydroalcoholic products applied to recently shaved skin (EDT).

CLASS 3B: 27.8%

Hydroalcoholic products applied to recently shaved skin (Fine Fragrance).

CLASS 3C: 27.8%

Eye products of all types (eye shadow, mascara, eyeliner, eye make-up, eye masks, eye pillows, etc.) including eye care.
Men's facial creams and balms. Baby creams, lotions and oils. Body paint for children.

CLASS 3D: 27.8%

Tampons.

CLASS 4A: 88.9%

Hydroalcoholic products applied to unshaved skin (EDT). Scent strips for hydroalcoholic products. Scent pads, foil packs.
Ingredients of perfume kits.

CLASS 4B: 88.9%

Hydroalcoholic products applied to unshaved skin (Fine Fragrance).

CLASS 4C: 88.9%

Hair styling aids, hair spray of all types (pumps, aerosol sprays, etc.). Hair deodorant. Body creams, oils, lotions of all types (except baby creams, lotions, oils). Fragrance compounds for cosmetic kits. Foot care products. Body paint for adults.

CLASS 4D: 88.9%

Fragrancing cream.

CLASS 5: 44.4%

Women facial's creams-Facial make up (excl. eye cream). Facial masks. Wipes or refreshing tissues for face, neck, hands, body. Hand cream. Hand sanitizers. Baby powder and talc. Hair permanent and other hair chemical treatments (e.g. relaxers) but not hair dyes. Dry shampoo or waterless shampoo.

CLASS 6*: NO DETERMINED

Mouthwash including breath sprays, toothpaste.

CLASS 7A: 16.7%

Intimate wipes. Baby wipes.

CLASS 7B: 16.7%

Insect repellent (intended to be applied to the skin).

CLASS 8A: 33.3%

Make up removers of all types (not including face cleansers). Hair styling aids non spray of all types (mousse, gels, leave-in conditioners, etc.). Nail care. Powders and talcs (except baby powders and talcs).

CLASS 8B: 33.3%

Hair dyes.

CLASS 9A: 83.3%

Liquid soap. Bar soap (toilet soap). Shampoos of all types (including baby shampoos). Body washes of all types (including baby washes) and shower gels of all types. Conditioner (rinse-off). Bath gels, foams, mousses, salts, oils and other products added to bathwater. Face cleansers of all types (washes, gels, scrubs, etc.). Shaving creams of all types (sticks, gels, foams, etc.). Depilatory.

CLASS 9B: 83.3%

Feminine hygiene-Pads, liners. Toilet paper. Wheat bags.

CLASS 9C: 83.3%

Others aerosols (including air fresheners sprays but not including deodorant-antiperspirants, hair styling aids spray and animal sprays). Facial tissues. Napkins. Paper towels.

CLASS 10A: 41.7%

Handwash laundry detergents of all types including concentrates. Fabric softeners of all types including fabric softener sheets. Other household cleaning products (fabric cleaners, soft surface cleaners, carpet cleaners, etc.). Machine wash laundry detergents (liquids, powders, tablets, etc.) including laundry bleache and concentrates. Hand dishwashing detergent including concentrates. Hard surface cleaners of all types (bathroom and kitchen cleansers, furniture polish, etc.). Dry cleaning kits. Shampoos for pets.

CLASS 10B: 41.7%

Diapers, toilet seat wipes.

CLASS 11: 100%

All non-skin contact or incidental skin contact Air fresheners and fragrancing of all types (concentred aerosol with metered doses range 0.05-0.5mL / spray):

Candles, plug-ins, solid substrate, membrane delivery, ambient, electrical... . Air delivery systems. Liquid refills for airfresheners and or fragrancing (every system with or without cartridges). Scent delivery system using a dry air technology that releases a fragrance without sprays, aerosols or heated oils (technology of nebulization). Air freshening crystals. Joss sticks, Incense. Toilet blocks. Machine only laundry detergent (e.g. liquitabs). Insecticides (mosquito coil, paper, electrical, for clothing, etc.). Fragranced lamp ring. Scent pack. Plastic articles (excluding toys). Fuels, paints, floor wax. Reed diffusers. Shoe polishes. Deodorizers/makers not intended for skin contact (e.g. fabric drying machine deodorizers, carpet powders). Machine dishwash detergent and deodorizers. Treated textiles (e.g. starch sprays, fabric treated with fragrances after wash, deodorizers for textiles of fabrics, tights with moisturizers). Infused socks. Scratch and sniff (sampling technology). Odored distilled water (that can be added to steam irons). Cat litter, animal sprays (all types).
